#### **Mayor's Bicycle Advisory Commission**

The Mayor's Bicycle Advisory Commission (MBAC) was first established in March of 2015 by Mayor's Executive Order and most recently reaffirmed by Mayor Scott's Executive Order in May 2021.

MBAC promotes bicycling and multi-modal transportation in the City and advises the Mayor and City Departments on these matters.

It is charged by the Mayor to:

- coordinate among City agencies the implementation and regular updating of the Bicycle Master Plan
- provide guidance and advice on policies, designs, trends and opportunities that <u>equitably</u> support bicycling, shared mobility, and multi-modal transportation in the City
- advocate for the prioritization of capital funding and operating support
- advise on the adoption of best practices in transportation facility design and related policies, including the City's Complete Streets Ordinance





#### Lime

- 2-vehicle permit, Scooters & Bikes (minimum of 75)
- 1100 vehicles with 75 bikes, 2000 with 150 bikes
- New scooter fleet, all new vehicles by Jan 1, 2022
- New \$1 incentives for parking in corrals
- Lime Access 70% off, plus 50% off automatically in EZ





#### **Bike Master Plan Update**

### In 2015, the City's Planning Commission adopted the Baltimore City Bike Master Plan




2015

- Plan created the vision for a city-wide bike network
- Established seven goals and associated objectives to achieve this vision
- DOT is responsible for implementing the network
- The Mayor's Bicycle Advisory Commission provides guidance and accountability



### Separated Bike Lane Network Plan (SBLNP) in 2017:



- Created a more detailed bike network and facility types for people of all-ages and abilities
- Identified main corridors that required separated lanes to safely navigate across the city
- Vision included 77 miles of separated and nonseparated bike lanes
- Estimated costs of \$27M to accomplish the separated and non-separated facilities to build over a 6 year period



### **2019 Update: Project Implementation**



2019

- Focused on active projects and implementation
- Included various phases of project
  development of design through construction
- Lane miles construction behind established goals
- Bike Program under resourced and understaffed to achieve network goals
- Next Steps for 2021 update



### **2021** Master Plan Update will include:

- Review 2015 Bike Master Plan's Goals and Objectives
- Determine if any Goals are missing and propose additional goals
- Determine if any objectives are completed or outdated
- Recommend objectives to be considered for addition
- Discuss partnership and roles for advancing objectives in terms of both execution and tracking



### **Major Questions**

- 1. Who should be the primary entity/agency responsible for each goal?
- 2. Are there major themes missing? (HINT: Equity, Community Engagement)
- 3. How does this overlap with the city's Complete Streets legislation?
- 4. Are any objectives obsolete?
